Open sea diving activities

The PIXSEA® 1300, designed to accommodate 32 divers and their pilot, features an open cabin at the front, providing sheltered piloting space. On board, modular facilities such as benches and bottle racks can be adapted to specific needs. Built in aluminum, this boat combines robustness and comfort. Its deck is cleverly arranged to allow a smooth flow of divers while preserving comfort on board; the PIXSEA 1200 is equipped with toilets.



The "GEN#4" hull of the PIXSEA range, developed by the architectural firm Œuvres Vives, combines performance and fuel economy while maintaining a good passage to the sea. This hull has fine water inlets to facilitate passage to the sea. The bow step or "beard" limits the spray.

Great attention is paid to the distribution of the volume to have a healthy behavior in three-quarters astern or split-wave seas.

About us



GENERAL TERMS AND CONDITIONS OF SALE 1/2

The following General Terms and Conditions of Commercial Sale govern all merchandise sales between BORD À BORD and the Customer. They apply to the contractual relationship between BORD À BORD and the Customer and form the legal basis for all sales, except where specific written agreements are expressly accepted by both parties.

ARTICLE 1 – APPLICATION OF THE GENERAL TERMS AND CONDITIONS OF SALE

These General Terms and Conditions are systematically provided to each Customer before placing an order. They apply to all sales of goods involving new motorboats and pleasure boats. By placing an order, the Customer fully and irrevocably agrees to these General Terms and Conditions of Sale, to the exclusion of any other documents such as brochures, catalogs, or promotional materials issued by the Company or the manufacturer, which are considered for informational purposes only.

ARTICLE 2 – ORDER – MODIFICATION OF GOODS – SALES CONTRACT

An order becomes final once a purchase order has been signed and accepted in writing by both the Customer and the Company. Any modification to the order must also be subject to a written agreement between the parties. Such changes will automatically lead to a postponement of the initial delivery date. The sale of boats will be formalized by a written sales contract.

ARTICLE 3. – DELIVERY

The delivery date is specified in the sales contract. For custom-made goods, the delivery date is provided for information purposes only. Once the Company confirms the timeline with its suppliers, it will inform the Customer and provide a final delivery date.

The Customer agrees to collect the goods at the BORD À BORD shipyard within 15 days following the confirmed delivery date. After this deadline, the Company reserves the right to cancel the sale without further notice and dispose of the goods. The Customer's deposit will be retained by the Company.

ARTICLE 4. – WARRANTY AND LIABILITY

4.1 COMMERCIAL WARRANTY

The Customer benefits from the Company's commercial warranty under the following terms:

A 1-year warranty applies to the aluminum structure of professional boats.

A 2-year warranty applies to the aluminum structure of pleasure boats.

A 1-year warranty applies to accessories.

The warranty is non-transferable and applies only to the original Customer.

Installation of the motor by anyone other than BORD À BORD personnel, or outside the BORD À BORD shipyard, is excluded from the warranty.

Any modification or intervention on the boat without the written consent of the manufacturer will void the warranty and may result in legal consequences.

The boat must be properly maintained. Damage caused by age, intensive use, or improper use is not covered by the warranty.

Any boat can be severely damaged if not used as recommended. Unsafe or non-recommended usage is incompatible with safe navigation. Speed and navigation should always be adapted to weather and sea conditions

If warranty work is required, it must be performed at the BORD À BORD shipyard. No off-site interventions will be covered under the warranty.

4.2 LEGAL WARRANTIES

In cases where the owner has altered the goods, maintenance, repairs, or the supply of spare parts must be carried out by a qualified professional or authorized repairer. Failure to do so will result in the forfeiture of BORD À BORD's legal warranty coverage.

ARTICLE 5. – PRICES

The sale prices of the Goods are those applicable at the time of signing the quotation or order form for standard boat models. The sale prices of the Goods may be adjusted at the time of ordering the raw materials and other components in the case of custom-made models or models that have been modified by a naval architect. In the event of specific requests from the Maritime Affairs Department, a certification or classification body, a maritime or river expert or other authority, during or after construction, additional costs may result in a price increase. In case of a variation of raw material prices or components of more than +/-5%, price could be readjusted. Transport prices are not fixed and may be updated at the time of delivery. Prices are quoted in euros, inclusive of all taxes (VAT included). However, the costs of removal, launching, handling, packaging, transport, delivery, parking, registration and customs are always borne by the Buyer. Any tax, duty or other charge payable under French regulations or those of an importing country or transit country shall be borne by the Buyer.

GENERAL TERMS AND CONDITIONS OF SALE 2/2

ARTICLE 6 – PAYMENT

6.1 TERMS

Unless otherwise specified in our quotations or purchase orders, the Buyer shall pay a deposit of 30% of the total price including VAT upon placing the order. This amount shall in no case be considered as a down payment ("deposit").

The goods shall only be delivered by Bord à Bord (EXW – Ex Works from the shipyard) upon full payment. Bord à Bord does not grant any discount for cash payments or payments made before the due date set out in these General Terms and Conditions of Sale.

6.2. DELAY

Failure to pay any amount by the due date specified in the quotation or purchase order shall automatically result in the application of late payment penalties equal to three times the legal interest rate. In addition to these penalties, a fixed indemnity of €40 will be charged to cover collection costs.

ARTICLE 7 – TRANSFER OF RISK

7.1 GENERAL TERMS

As of the moment the Goods are delivered—including when still located at the premises of Bord à Bord, the risks—particularly those of loss, theft, damage to the Goods or caused by the Goods—are transferred to the Buyer, notwithstanding the retention of title as stated in Article 9 below. Consequently, it is the Buyer's responsibility, from the moment the risk is transferred, to insure the Goods against theft, fire, or any other form of destruction, damage, accident, or loss. The Buyer must also take out liability insurance. Bord à Bord disclaims all liability for penalties related to operational loss due to vessel immobilization. The Client agrees not to seek compensation from Bord à Bord beyond what is covered by their insurance policy.

7.2 IN THE CASE OF AN INTERNATIONAL SALE

For sales of goods intended for export, the transfer of risk and costs shall take place in according to the ICC Incoterm mentioned in the quotation or purchase order, based on the latest version in force at the time the offer is issued.

ARTICLE 8. – RETENTION OF TITLE

Ownership of the Goods shall remain with Bord à Bord until full payment of the purchase price has been received.

ARTICLE 9. – MISCELLANEOUS PROVISIONS

If one or more provisions of these General Terms and Conditions of Sale are rendered invalid by a legal or regulatory provision, or by a court decision, the remaining provisions shall remain fully enforceable.

ARTICLE 10. – FORCE MAJEURE

The occurrence of an event of force majeure shall result in the suspension of Bord à Bord's contractual obligations. An event of force majeure is understood to mean any circumstance beyond the control of Bord à Bord that disrupts its normal operations at any stage of production or shipment of the Goods. This includes, but is not limited to: total or partial strikes (including those of its suppliers, subcontractors, or carriers), interruptions in transportation, energy supply, raw materials or spare parts, as well as pandemics and epidemics.

ARTICLE 11. - APPLICABLE LAW - JURISDICTION

Any disputes relating to the application of these General Terms and Conditions of Sale or to services provided by Bord à Bord shall fall under the exclusive jurisdiction of the Commercial Court of Saint-Brieuc.
